1. Discussion from the Service Department. Mr. Schroedel

a. **Logging**

Mr. Schroedel stated that we have 2 applications for permits for logging and both of these stemmed from the storm that we had blow through here a couple of months ago that knocked all the power out and a lot of trees fell. One is Mr. Wilmot on Boston and Broadview and one is Mr. Mull on Broadview close to our Rec Fields. The Engineering Department and the Building Department and he all walked the properties. While they are taking enough trees down to classify as logging, we do see that their requests are reasonable. A lot of the trees are already down and they are taking some large trees down. The one by the Rec Fields, there are trees extremely close to his house within 5 feet of his house he would say even. In the case of the Wilmot's, the ODNR is running the project. They have come out, they have marked the trees and ODNR will actually bid out the project and pay for it because it is zoned a certain forestry type of land. The administration recommends it.
