REPORTS AND COMMUNICATIONS FROM DEPARTMENT HEADS AND OFFICIALS

Mrs. Horner stated that she would like to update council and the residents on the progress on the new community and recreation center project. To make way for the renovations included in the project the existing pool has been closed along with the aquatic offices and support spaces. The areas closed have been cleared out by the Parks & Recreation Department and Service Department staff. Panzica's demolition work has begun. Our partnership with the City of Seven Hills which took effect on April 1st provides our patrons with pool access while we are without a pool. Many of our members and residents have already been taking advantage of the opportunity to use the aquatic facilities in Seven Hills. The staff at the Seven Hills Recreation Center has been very welcoming to everyone. Things are moving along very quickly in the new portion of the building. The concrete slab has been poured in the locker rooms and the mechanical, electrical and plumbing along with masonry work is underway in that area. The concrete slab has been poured in the gymnasium and the track is being installed around the perimeter. The concrete slab will be poured in the lobby and hallway areas this week. The new natatorium is taking shape. The concrete was poured last week for the hot tub and the concrete is expected to be poured for the rest of the pool this week. The natatorium roofing is currently being completed and the roofing is already complete over the remainder of the building. Internally they continue to finalize all of the furniture, fixtures and equipment that will be going into the

new building. The furniture has been selected and quotes have been finalized for the fitness equipment, the lockers and the group exercise flooring. They are still working to finalize that master list. They are also still finalizing the signage for the new building and working to update items such as vendor contracts, facility rules, fees and charges, policies and procedures, etc. Their management staff just recently completed a week long training program required to upgrade their software system that will be used in the new facility. The project is still running on schedule and an anticipated opening between October and December of 2018 and regular construction updates with pictures and videos can be found on the Parks & Recreation Department Facebook page by searching at bvhrec.

Mrs. Washabaugh stated that the Center for Community Solutions published a city fact sheet today and she has handed that out to all of council. It gives a great snapshot of the different types of demographics here in Broadview Heights. The next AARP driver's safety program is May 10th from 9-1. They ask that you arrive at 8:30 a.m. and it is \$15 for members and \$20 for nonmembers. Please call Human Services to register. Through the grant that they have received from the Ohio Arts Council, the Cleveland Tops Swing Band along with the Brecksville-Broadview Heights Middle School Jazz Ensemble will perform a free concert on Thursday, May 17th at 7:00 p.m. at Brecksville Human Services.

Mr. Schroedel stated that the Service Department has a couple of big jobs going on, one on Falls Lane and one is completed on Marianna. They are continuing to do pothole repairs every day that it is not raining. The Historical Society Building is coming along nicely. The grout is being prepared for the footers and the slab for the Spotlights Building. He would like to commend the custodial workers, they got in to Building 16 and 18 where the Steps Academy is going and they really did a fine job. They re-waxed the floors; they cleaned all of the carpets and really made it look nice for the new tenant. Our facilities guys are going in where the pool is getting filled in and we are salvaging everything that we can out of that area. We are working on putting some electric out by Fire Station 1 on Wallings in anticipation of the new digital sign that should be installed shortly.

Mr. Yelenosky stated that he just wanted to update council with 2 ongoing construction projects, East Mill and Wright Road. On East Mill they are shifting over and working on the east lane. They have cut all of the concrete out and they will be working towards the end of this week for a final pour this Friday and hopefully pave next Monday weather obviously is the only hurdle that we have to deal with. Wright Road, they are continuing working on the water line and getting near Sprague. We anticipate being done with the main line this week and starting service connections early next week. If anyone has any further questions on the status or current updates he would be more than happy to share those.

Ms. Sorensen stated that this past Friday they held the Veterans Military Resource Fair here at the Community Center. Mrs. Washabaugh's department put that on. She also knows that the Service Department helped out and we had a lot of local businesses contribute. There were about 350 veterans that came through that were able to receive services and/or resources so they wanted to give a shout out and thank you to Giant Eagle especially for all of the food that they provided and for all the local businesses that provided health and haircuts and all kinds of stuff. Also, as you know that we like to support new businesses in town and kind of get them off on the right foot and welcome them so next Friday we are going to be having a double ribbon cutting. There are 2 new businesses in town that are looking to open their doors to us, welcome people in, show us a little bit about what they have to offer so next Friday at 10:30 there will be an Open House and Ribbon Cutting for VIP Nails which is a salon over in The Crossings and then an hour later across the street the Macaroon Tea Room will be hosting a Grand Opening and Ribbon Cutting at 11:30 in the WellPoint Plaza.

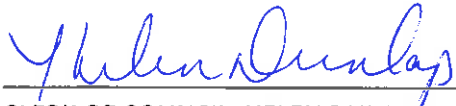
