Mr. Yelenosky stated that he would just like to update city council on Wright and Overlook projects that are going on. On Overlook they are starting to chlorinate the line this week in anticipation on starting the service taps next week and on Wright Road they are going to finish up the taps this week and we should have pavement removal starting hopefully Friday this week if not early next week.

Ms. Sorensen stated that as everybody probably knows and is familiar with Cleveland Magazine's rating the suburbs, she wanted to let council know that we were notified that we were bumped up 10 spots to #8 out of 77 suburbs for one of the best places to live in NE Ohio. They come to this categorization basically due to a comprehensive data and report that we submit over to them and there are factors that they used in giving us this rating. They are weighed heavily on safety, education, housing, public services, diversity, walkability, median home prices and development projects. She just wanted to let everybody know that this is a team effort and it looks like we all did a great job.

REPORTS AND COMMUNICATIONS FROM THE MAYOR

Mayor Alai stated that around 8:30 this morning he received a text page of a working fire at 8603 Scenicview in the Condos there. By the time that he got there the building was totally engulfed and our police got there and knocked on some doors to make sure that nobody was in there. The fire departments responded from Brecksville, Seven Hills, North Royalton and Richfield. It was a tough fire for them, it was already up into the walls and into the ceilings and the wind was really whipping around but they worked really hard and got the fire out and under control. We have 10 households that are displaced and with the help of the Red Cross, our Human Services Department and other people, these people have places to stay this evening. We gave them some gift cards and things like that but he not only wants to talk about police and fire response and of course Human Services, Mr. Schroedel was there today and even the Dog Warden comes out to make sure that no pets are lost and no loss of life, no injuries, but what really astounded him after all of that fine work from all those departments was the outpouring from residents and emails that he received and phone calls from residents just wanting to help people. A couple of them owned condos that had a couple empty and ready to let residents move into the condos that they have vacant so that people have places to sleep, school board members called him, Chamber of Commerce and residents so it is just great to see in this tragedy for some people's lives that their whole world went up in flame and the only thing that they had were the clothes on their back to see the outpouring of help and it just tells you why we are rated #8 in the suburbs because of what the people. It is not about us, it's about the people that live in the city that make it what it is and he is touched by the outpouring and Mr. Stelmaschuk came up there to talk to the residents as they were gathered today and it just shows what kind of community that we live in and we should be proud of the community that we live in.

Mr. Wolf stated that on that note for being #8 it is also the schools. So the Brecksville-Broadview Heights Schools had their graduation ceremonies and it was great and hopefully the kids will flourish and do great things after and we will hear from them.

Mr. Boldt stated that with that said, he thinks that #8 we robbed. He really does. He thinks that it is better than #8 and maybe when they are done with the rec center it should go up but he thinks that #8 is low.

Mr. Stelmaschuk stated that he was on scene also this morning and he was very impressed with the mutual aid with all the different cities here working together, very touching. Also he drove down Rt. 82 heading to the west yesterday and contrary to the negative coverage from a certain media outlet, neither one that is present here today, the planters look spectacular so the city did well with that. It is a great entrance piece and it looks very nice and if you haven't seen it he recommends that you drive down there and check it out.

Mr. Price stated that on a little redirection he wanted to thank the Mayor and especially Mayor if you would pass it along to your staff for once again really setting the mark for the City of Broadview Heights when it comes to Memorial Day and remembering our Veterans and how the Mayor is able to pull of the weather each year he has no idea but someone up above is most certainly looking down upon this community.
