## **GET OUT AND VOTE ON ISSUES 15 & 16: The proposed expansion of the current Broadview Heights Community and Recreation Center**

On November 3, voters in Broadview Heights will have the opportunity to vote on the expansion of the current Broadview Heights Community and Recreation Center. The proposed expansion, which includes renovations to the current facility as well as new construction, will offer something for everyone. Included in the plans are: a new aquatic area with lap lanes, lazy river, waterslides, activity space, zero depth entry area with play features, large doors that open to a sundeck, modern locker room facilities, additional family changing rooms, a sauna, steam room and whirlpool. There will be a new state-of-the-art fitness center, a new indoor walking and running track, expanded childcare services and a new gymnasium with 2 full courts for activities such as basketball, volleyball, pickle ball, indoor soccer and batting practice, as well as additional sports and fitness programming. The new facilities will also offer dedicated time and space for seniors.

Voters will see two issues regarding the expansion: Issue 15, a 0.4 mill 15-year operating levy, and Issue 16, a 1.42 mill 25-year bond issue for new construction. If the operating levy passes, residents' rates will remain the same, covering the increases in operating costs of both the current and proposed facility.

The opportunity to vote on these issues is now just over one week away. This is the chance for residents of Broadview Heights to determine the future of the Broadview Heights Community & Recreation Center. Make your voice heard by getting out to vote.

### **CARTONS ARE NOW PICKED UP AS RECYCLABLES**

The last drop of milk, juice or soup does not mark the end of a carton's useful life. Made mainly from high-quality paper, cartons are easily recyclable and in high demand by manufacturers of recycled products. Recycling is easy -- simply place your empty cartons in your blue bags containing your other plastic, metal and glass containers. After cartons are collected curbside, they are taken to a MRF to be sorted and baled. The bales of recycled cartons are then shipped to paper mills, where cartons are mixed with water in a gigantic blender to extract all the paper fiber. These recycled carton paper fibers are a valuable resource for making products such as recycled paper products and even building materials.

### **LEAF COLLECTION CONTINUES**

The crews will continue in AREA "B" as per the schedule that appeared in the October BroadView Journal. You can also [download the schedule here](#). Rake leaves to the tree lawn before your scheduled week. Do not put them in the street! Leaves with grass and/or branches will not be picked up. (Note: If the crews finish an area ahead of schedule, they will jump ahead to the next area,

but will return on the regularly scheduled day.) As an alternative, leaves may be put in biodegradable bags and placed with the regular trash.

## IN CASE YOU MISSED IT...

- **FEEDING ANIMALS PROHIBITED**

Broadview Heights Ordinance 618.20(2) states, *“No person shall provide food for dogs, cats, deer, geese, ducks, raccoons, fowl or other wild animals or wildlife by setting such food out on any public property or within a 150-yard radius of any private residence or public roadway. This section does not apply to animals owned by the person or to songbirds fed from a stationary bird feeder.* Furthermore, (b) states that *“Whoever violates this section is guilty of a minor misdemeanor for the first offense and a fourth degree misdemeanor for a second or subsequent offense. Penalty shall be as provided in Section [202.99](#) of these Codified Ordinances.*

- **NO OVERNIGHT PARKING ON CITY STREETS:** Please remember that Ordinance No. 452.05(c)(1) prohibits parking on city streets between the hours of 3:00 a.m. and 6:00 a.m. Ordinance 452.20(a) requires that signs be posted at city limits.
