### A.A.R.P. TAX PREPARATION ASSISTANCE

AARP Tax Preparation Assistance will be on Tuesdays at Broadview Heights City Hall Council Chambers by appointment only. Registration begins Monday, January 4, 2016 in-person or by calling Human Services Department at 440-526-4685. Dates are February 2, 9, 16, 23, March 1, 8, 15, 22, 29, April 5, 12.

#### Items taxpayers must bring to their appointment:

- Photo identification (driver's license, state ID, etc.)
- Social Security documents (Social Security cards for taxpayers and dependents),
- Form W-2s
- Form 1099s
- Support for other types of income

- Support for deductible expenses Note: All charitable contributions, medical expenses, prescriptions etc. must be listed and summarized when presented to the volunteer tax preparer.
- Prior Year tax return copies
- Death certificate if filing for a decedent

The following list represents out-of-scope situations when the A.A.R.P. will **not** be able to provide assistance:

- Schedule C (Business Profit and Loss)
- Schedule D (Capital Gains & Losses) without supporting paperwork
- Schedule E (Rental Property) with expenses including depreciation
- Schedule F (Farm Income)
- Schedules K-1 that involves depreciation or deductible expenses
- Form 2106 (Employee Business Expenses)
- Form 2210 Underpayment of Estimated Taxes by Individuals, Estates & Trusts
- Form 2439 Notice to Shareholder of Undistributed Long-Term Capital Gains
- Form 3903 (Moving Expenses)
- Form 4136 Credit For Federal Tax Paid on Fuels
- Form 8606 (Non-deductible IRAs)
- Form 8615 (Minor's Investment Income)
- Form 8839 Qualified Adoption Expenses
- Form 8885 Health Coverage Tax Credit
- Claim for Mortgage Interest Credits
- Taxpayers who must file Form 1116
- Returns (original or amended) farther back than 2 prior years
- Taxpayers affected by Additional Medicare Tax (AGI > \$200,000, single: \$250,000 joint)

There are many other <u>out of scope</u> items that only occur occasionally and are too numerous to list.

- NO PARKING ON CITY STREETS WHEN SNOWFALL EXCEEDS 2"
   Ordinance 452.13 specifies that a snow-emergency parking ban exists when snowfall exceeds 2" in a 24 hour period. Use common-sense when parking in the street during the winter so that the roads can be properly cleared.
- NEW COMMUNITY AND RECREATION CENTER ADDITION
  These are exciting times for the Broadview Heights Parks & Recreation Department! The
  Recreation Bond Issue (Issue 16) passed and the new community and recreation center
  will be built. The tax levy for the additional operating costs (Issue 15) did not pass. We
  would still like to keep the membership fees the same for residents and will be working on
  alternate plans to cover the additional operating costs.
- FEEDING ANIMALS PROHIBITED

  Broadview Heights Ordinance 618.20(2) states, "No person shall provide food for dogs, cats, deer, geese, ducks, raccoons, fowl or other wild animals or wildlife by setting such food out on any public property or within a 150-yard radius of any private residence or public roadway. This section does not apply to animals owned by the person or to songbirds fed from a stationary bird feeder. Furthermore, (b) states that "Whoever violates this section is quilty of a minor misdemeanor for the first offense and a fourth

degree misdemeanor for a second or subsequent offense. Penalty shall be as provided in

Section 202.99 of these Codified Ordinances.
 NO OVERNIGHT PARKING ON CITY STREETS: Please remember that Ordinance No. 452.05(c)(1) prohibits parking on city streets between the hours of 3:00 a.m. and 6:00 a.m. Ordinance 452.20(a) requires that signs be posted at city limits.
