## **CONTRACTOR REGISTRATION INSTRUCTIONS & CHECKLIST.**

Any and all general contractors, specialty contractors, subcontractors and landscapers performing any work within the City, (regardless of whether a permit is required) shall be required to register with the City and the Regional Income Tax Agency (RITA) prior to beginning any work in the City. Contractors who begin work in the City without first registering may be subject to additional fees, a stop work order and/or a court citation. Attached are the forms that need to be completed for your company/trade.

### **ANY APPLICATION MISSING ANY INFORMATION WILL NOT BE PROCESSED AND WILL BE RETURNED.**

**[ ] NOTIFICATION:** If you do not submit your application in person, you must provide a self addressed stamped envelope with your application. Your certificate will be mailed to you through regular mail. No emails.

**[ ] PAYMENT:** We accept Cash, Check, or Credit Cards in person but only checks or money orders through the mail. Make checks out to the City of Broadview Heights. The fee of the annual registration during any time of the year, is one hundred dollars (\$100.00). No refunds.

**[ ] CONTRACTOR CATEGORIES:** Those engaging in work as a registered contractor, either by hire, contract or subcontract, shall be registered for each classification type. The wording of your classification must match the wording on the bond. You may state an additional classification type on the applicaiton **ONLY** if both classification types are listed on the bond. The following contractor categories **MUST** submit a Current State License with their application: **Electric, Plumbing, HVAC, Refrigeration, Hydronic, Fire Supression, and Fire Protection.**

**[ ] BOND:** A twenty-five thousand dollar (\$25,000.00) bond is required for each registration. The bond shall be on a **Broadview Heights Bond Form** with your insurance company's seal/stamp and a Power of Attorney attached. The bond expiration date shall be December 31st annually. No Continuation Certificates will be accepted. Either the principal or an authorized representative of the company named **MUST sign the bond form.** We will only accept the "original" stamped/sealed bond form through the mail or in person. No copies, emails or faxes will be accepted for the bond. The bond form may be downloaded by your insurance company from the City's website: [www.broadview-heights.org](http://www.broadview-heights.org)

**[ ] CERTIFICATE OF INSURANCE:** The Certificate of Insurance must list bodily injury \$100,000/\$300,000. and property damage of least \$50,000. The City of Broadview Heights must be listed as a Certificate Holder. The Certificate of Insurance will expire on December 31<sup>st</sup> of the current year.

**[ ] WORKER'S COMPENSATION:** A Copy of your Current Worker's Compensation Certificate must be included. If you are a **SOLE** Proprietor with **NO EMPLOYEES** other than yourself, you must note the fact on the application. All Worker's Compensation Certificates expire on June 30<sup>th</sup> of each year. It is your responsibility to submit a new certificate.

**[ ] RITA BUSINESS REGISTRATION FORM 48:** If **you are not** currently paying taxes to RITA in Cuyahoga County, you must fill out and submit **FORM 48** online at **RITAOHIO.COM**. If you have a Federal ID Number you must list it on the Contractor Registration Application. **It is the responsibility of ALL contractors to notify RITA at RITAOHIO.COM with the number of days & locations of work that the company does in Broadview Heights.**

### **IMPORTANT NOTES:**

- All Contractor/Building Trade Registrations shall expire on December 31<sup>st</sup> of the year of issuance.
- All Workman's Compensation Certifications expire on June 30 of every year.
- The expiration of any of the required documents may delay permit approvals and inspections for the project. It will be the responsibility of the Company or representative to submit new documents when they expire.
- All Certificates must be re-submitted each year with your registration, regardless of expiration dates.
- **Bonds that are cancelled by your insurance company for any reason will also cancel your registration.**
